NEWSLETTTER: Approved

Lord Ronin admitted the that our own was a week late in posting. Marty also mentioned he had received confirmation from us about receiving the disks. As well as the scarcity of 3 1/2" <1581 disks>.

Shop has recieved several requests about the group and C=/Amiga items for sale. Most recent arrived on meeting day. Lord Ronin said that the original papers he and #30 had created were lost. He would do a new listing and make a mailer in GeoPub to send out to the people.

Amiga Librarian: "Amiga now on DSL Broadband Internet" When asked what the frell that was? "DSL = Digital Subscriber Link. A Phone line able to handle digital Internet and phone line <voice>. Broadband is a superiour high speed Internet connection. Usually requires you to connect with an ethernet device."

Asked then what the Amiga uses for this sort of thing. "X-Surf II ethernet board allows Amiga connection to the DSL modem." Asked to explain a bit simplier for the group as to what this does. "Inet connection way faster than before and does't tie up the phone line. Another thing that is nice about it, is that multiple computers and or other electronic devices can be connected simultaniously." Examples were given of things like the Play Station 2 and the Game Cube. Plus a short talk on connecting the 128 with wave.

I showed at demo how the work was done. In fact was doing one before meeting started. That is why it opened five minutes late. In order to keep the flow of this topic and explain the point. I'll go over it in this part.

On the really bad 81 disks. The drive will choke and give me a read 23 error or a write error. Generally in the same locations. However I found out by pure accident that the files that are finally zipped. May still be bad! As when unzipped they drenn out with a CRC error.

That is what happened just before the meeting on a 1993ce disk. Used that as an early demo before the meeting. Showing that all files have to be unzipped before they can go on the BBS. Just to be certain. This does cause a worry about some that I made earlier that I didn't test.

from gamefaq.com, is now on the BBS. This is the Labyrinth one and the game is also on the BBS. I want to thank Scratcher of Onslaught for the .D64 files he sent of the game. As I was unable to preserve the copy that I sold through the lnet. **#30** and **#3** are going to work on more of them for the BBS and the Village Green. There will be a few parts to the Labyrinth one in the V.G.

Board has been backed up more frequently. Not as often as it should. Looks like we will soon be making some large changes in the File nodes. Specifically the Arcade Games. A new data store needs to be created. Something on the theme of "Action Adventure". Need something better in description than that! Since we have found a wider variety of education programmes. We are going to rename and add new educational data stores. These jobs are in the near future as it is a long testing process of the files. As well as a delicate adjustment to the settings on the BBS.

Deputies: #30 working on the new walk throughs. #3 also on the new walk throughs and note translation. Neither she nor LR can read his notes. #23 is testing all the aspects of Star Colony Deluxe, Star Colony, Empire Deluxe. Making notes for not only new review/help files. But any bugs. tools. That is the other side of what is happening in programming. Add to that a crack and scan of some Assembly books. Plus Rod at VCS is giving help and support on the Assembly information.

GEOS; Collection of salvaged files. These are to be tested by LR and #30. As some of them are not that responsive in Wheels. Plans for the reverse printing tests when funds allow.

GODOT; Decided that all files must be re-downloaded. That way the updates will be included. New disk will be issued and the files will be on the BBS. Replacing the current ones.

Demos: Making a "veult" file. #4 mentioned that he hadn't seen the puzip.c64 in action before.

Page Streem 2 and using the text and columns, m a special setting. As some work that **130** was doing needed explanation on the Amiga.

Discussion: Starter Disks; creating a new one for members. But also making periodic updates. This one needs more thought and discussion.

Amiga Editor makes it to Broadband

Hello all, here's the promised article on my experiences with getting my Amiga on Broadband internet. *Delving With Dungeon Master* will continue next month.

Well, one thing that got me back to catching up (again) on my e-mail is I just got my old A4000 on DSL. (Digital Subscriber Line, IIRC) I know some of the Amiga guys would be interested in how I got on.

My system: A4000 desktop motherboard in a Power Tower case Stock Commodore 68040-25mHz processor board 16MB Fast, 2MB Chip RAM PicassoIV RTG board - Picasso96 Software AmigaOS 3.9 X-Surf-II Ethernet card A2091 SCSI Card with GuruROM (For a SCSI CD-burner) Miami v3.2b Genesis (OS3.9 CD version) iBrowse 2.3 Actiontec 1524 DSL Modem/Router

Ok, I have a bunch of other software running, but it's not too relevant here.



I had ordered my X-Surf from Compuquik, but due to the fact that we had a big snow/ice storm hit the North West, it was a few days late. But when it came in, It was sitting next to the box with my DSL Modem/Router. All the parts were there on the same day so I was ready hook some stuff up.


First the X-Surf II. From what I've heard, the only difference between this one and the first version is that the first version also had the BNC (Coaxal cable-looking) ethernet connector (The bit that sticks out on the right side of the picture above,) as well as the TP or Twisted Pair connector. (That one looks like an over-sized phone jack,). BNC has fallen out of favor I guess since all computers are talking on one wire.

Installation is as easy as any other Zorro-II/III expansion board. This board was a bit of a tight fit, so be careful. As usual for a board by Jens Schoenfeld, the board is very clean-looking. The install CD however didn't have a label and just looked like one that the vendor may have just burned on the fly. The board also has two IDE ports (one for the 3/5" drives, one for the 2.5" drives) that are non bootable. (It requires me to have the proper file in my Workbench's expansion drawer to get them going.)

The X-Surf II also has 2 clockports for expansions such as the Silver Surfer (a highspeed serial port) or a Catweasel (allows use of floppy drives made for Windoze boxes.) There is a 26-pin expansion port suitable for the VarIO board, a board that has a highspeed serial port as well as a fast parallel port. Full specs, ect can be found at http://www.jschoenfeld.de

The X-Surf ran me \$135 + \$10 shipping (USD) From Compuquick Media Center. (http://www.compuquick-amigadirect.com/)

The Actiontec 1524 modem was really nice. It has a built in router so I didn't have to worry about Miami not supporting the PPPOE protocol. The router dealt with that so all I needed was a good ethernet connection to the modem. The modem has 4 ethernet ports, 1 USB port, and expansion slot(s) on one side for a wireless adapter. This is a leased modem from Qwest, so I have no idea how much this thing costs.



I also had in the modem box some special filters for use on my phone lines. This allows me to use the phone while I'm connected to the internet. However, since my only phone jack is right next to the computer, all I had to do was connect my modem to the phone jack and my main phone line (to a splitter I use,) into the modem. It seems to have it's own filter built into the modem so I didn't need any of the external ones.

I'm currently having trouble with my CD-ROM so getting the X-Surf CD to read was a bit of a pain. In fact my drive had completely given up the ghost, but not before I was able to copy the CD's contents to my Harddrive as well as do an install. The install of the software was as simple as running the usual Amiga install script and answering the prompts. The install gives you a choice to have it set itself up for Miami or Genesis. Since I use Miami to connect to the internet, I selected Miami. I messed up on the first time since I gave my computer the same IP address as the router (192.168.0.1). Rerunning the install script fixed that quickly. (If you use the X-Surf software to setup your network, do not set you computer as #1 if you have a similar setup. LOL)

The X-Surf software also installed Samba (some file sharing software for easy exchange of files between an Amiga and a PeeCee.) NetFS (Amiga-specific file-sharing software) was installed as well.

In the XSurfEthernet drawer all I had to do was double-click the StartEthernet icon and my network was up. StartEthernet is a script file that fires up the Samba and NetFS software as well as Miami. The script was setup to have Miami load a special config file, leaving my old default config untouched. This was a nice touch in case I had run into trouble.

Now I had to setup the modem. I fired up iBrowse and typed in the IP address of the modem. (192.168.0.1) Remember that this address is only valid on your local network and not accessible from the outside. (IIRC) I got the html startup page for the modem. Clicking on Setup/Configuration brought me to a page that included the option of Non-Windows setup. Thanks go to the people that realized that Bill Gates is not in all computers. LOL Anyhow I filled in the proper configuration as outlined in the ISP "worksheet". I then nit the "Save and Restart" button on the page and the modem was setup.

All I had to do now was wait for the "Internet" light on the modem to stop blinking. When it turns to a steady light, I would be on the Internet. When it finally stopped blinking, I gave it a try.

I had immediate trouble. I wasn't going anywhere online. I could get the modem, but nowhere else. I had the sudden inspiration to try adjusting th settings on Miami to see if that fixed things. To make a long story very short, I discovered that if I went to "Interface -> SANA-II Configuration" and change the "IP Type" from "Static" to

"DHCP" I was able to access the web.

As an experiment later, I tried using MiamiInit to setup the network without all the Samba/NetFS settings added to Miami. MiamiInit at the end said it couldn't find the DNS servers at the end, but I hit continue anyway. Comparing the difference between the working settings and the MaimiInit settings, all I had to do was in "TCP/IP" uncheck the box by "Use ICMP". iBrowse had no problem accessing the web.

Another experiment was to setup the network to use Genesis. This is a bigger problem. The X-Surf and Genesis Wizard setup couldn't get me web access. Setting the IP Address to "dynamic" on Genesis didn't work so I'm a bit stuck on how to get it up and running. This wouldn't be a big deal if Keyfiles for Miami were not impossible to get. Perhaps some help here so non-Miami users can do this would be nice.

On to the Internet itself. Webpage loading with iBrowse is very quick. Most of the time is probably waiting for iBrowse to render the pages or getting them off of a slow server. But still very fast and very nice. Downloading a file of around 1.5MB got transfer rates of around 50k cps. I'm working on tweaking my setting for iBrowse a bit to see if I can speed up loading of websites a bit.

YAM, my e-mail client is a bit quicker. However, since it downloads each e-mail message one at a time, it creates a big bottleneck on my download speed. Large e-mails do benefit more from the faster connection though.

When I signed up for Qwest DSL I had some choices for who my provider would be. They were M\$N, Qwest.net, or a third party provider. (The latter being the most expensive. Since I didn't like the idea of having MicroSloth as part of my e-mail address, and the fact that Qwest.net had a Usenet server (for Newsgroups,) I went with Qwest.net.

I'm keeping my old provider for a couple of months as I start to change over to the new e-mail address. However, Qwest.net is having trouble with their computers and cannot change my (or anyone else's) user name or set up other email addresses right now. When that's fixed, I'll start using the new e-mail address. One nice thing is that I can still grab my e-mail from my old provider using the DSL connection. This gives me a good idea of how fast my e-mail handling is going to be.

How fast is all of this? Well I was using dialup with a 56k modem. When they fixed my phonelines so I could get DSL, I was getting connections of around 49k or higher. (Before that I was around 26k-28k.) My DSL connection is rated at 640k download and 256k upload. Why is sending information slower then receiving? This is pretty common since most users are downloading much more information then they are usually sending up. It's still much faster then what I had before.

I hope this was informative to those of you who are thinking of going Broadband. I don't know how tricky hooking up to Cable internet is, but maybe this will give you some ideas.

[Some stuff I worked out after writing the above:]

OK, I got the static IP setting to work. What I needed were the DNS numbers to put in the right section of Miami in order to get it to work. Strangely, Genesis is still not working. More figuring out to do there.

I got my Broadband adapter for my Gamecube. When I'm grabbing e-mail and playing Phantasy Star Online, I don't notice any interference or lag on either system. So far so good.

The ISP hasn't yet fixed their system so I can get my user name fixed. I'll call them again soon.

As she won't let an image out of herself. Our No. 23 selected this statue as a representation of herself. Something about her younger days (g). Like many of the others. This one was painted in the 1980s. The statue is about 4" tall in this seated posture.

hair is a straw blonde. The dressing yown is a different matter. This one us a purple. [Shades of S. holmes] The paint is a silk and satin. As can possibly seen with the slight shine on the arms in the image. Maiden flesh was used for the body.

high detail on the shoes and garter belt. Which are lost in the image. The actual statue is used for a character in the game heroe 's Unlimited by Paladium Games. A super hero game. Or in her case, Super heroine [G]

Pnother one of the statues in the collection. This one

is about 2 1/2" tall. Slightly bent over at the waist. One thing that we have noticed. There is a tendency to fatten out the image. New tests with an in Camera feature will be used in the future for experiments.

This character is named Lunatay. Plays in the RJ&J version of the Thieves World Mythos. Colours used on the painting were "maiden flesh" the hair "jet black. "G-String" silver/purple.

Figure was painted back in the **1980**s. Probably could use a repaint sometime **(G)**. This one does not have a clear shine sealer. Keeps a lot of the light problems down on this particular shoot.
